Every PT organized by TestQual is based on the UNE-EN ISO/IEC 17043:2010, the design is focused to allow the evaluation of the quality of the analysis and results from our participants. Our PTs apply a statistical design as stated in international references like ISO 13528 Statistical methods for use in proficiency testing by interlaboratory comparison and the Harmonized protocol for the proficiency testing of analytical chemistry laboratories from the IUPAC.

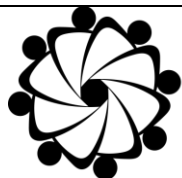

In addition to that, as stated above, we obtained a certificate for our website so you can navigate it knowing your data is secure.

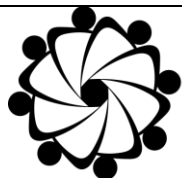
### QUALITY CONTROL MATERIALS AND BLANK ITEMS

In our website you can find at your disposal various Quality Control Materials (QCM) from our PTs as well as Blank matrixes, previously analysed to ensure that they are fit as blanks. Both items can be acquired from our website or contacting our team, you can find our contact data below.

### HOW TO START WORKING WITH TESTQUAL?

If you wish to acquire any of our services and you do not have an account on our website, you can follow the next steps:

1. Enter our website and start a new registration at <http://www.testqual.com/registro/?lng=en>.
2. You must fill in the required information (laboratory name, VAT (Fiscal number or code to identify your company), shipping address, contact data, etc.).
3. Once you have finished and sent the form, the TestQual’s page administrator within the next 24h will notify you when your account has been activated.
4. Once your account has been activated you will be able to log in using the credentials (email and password chosen during registration) and send any application to any PT or order any QCM.



5. In case some information was missing during the registration, someone from the TestQual team will contact you to confirm with you your company data.

### HOW TO APPLY FOR A PROFICIENCY TEST?

1. Check the available proficiency tests on the link: [www.testqual.com/proficiency\\_tests/?anio=2021&lng=en](http://www.testqual.com/proficiency_tests/?anio=2021&lng=en).
2. The page of each proficiency tests contains the protocol in PDF format (right column) and in the bottom and top of the page you can start your application by clicking "Participate".
3. Login to your account with your email (user) and password.
4. Select the matrix/es available for the proficiency test and enter your LOQ that your laboratory will analyse.

During the application you can find helping tools to make easier your application (use the same LOQ from past participations or apply the same LOQ for all analytes).

All analytes left as NA (Not Analysed) will NOT be requested when entering the results.

5. Click on accept, review that all the data is correct and confirm the application.
6. The website administrator will review your application within 48h and you will be contacted with your confirmation of your inscription or if any information was missing.

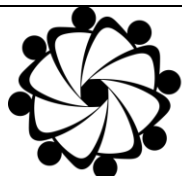
You can check if you sent correctly your application by logging in to your client area, selecting the dashboard on the left column and if the application was received correctly it will appear in "pending", if it is empty, then, a laboratory code for your participation will have already been assigned.
