- 70 \$ courier fee will be added for each round sample sent countries except Turkey.
- Additional samples will be quoted with the same round prices.
- Details about test methods and samples will be defined in related instruction forms.
- Annual plan also will be issued in new website TahalabPTS soon.

**TERMS OF PAYMENT**

1. Payments should be made to related bank account until deadline defined for PT scheme invoices.
2. For participants who doesn't make payment until deadline of related scheme, samples for next proficiency test scheme are not sent and for existing scheme results of related participant are not included in statistical evaluation.
3. Participants should make payment for whole amount of invoice. In case of shortage of payment, missing amount is included in next invoice.
4. Requests for cancellation of registration after delivery of samples are not accepted. In such cases sample prices are invoiced to participant.
5. If samples are damaged based on participants, additional sample requests are invoiced to participant laboratory.
6. It is important that participant laboratory should define sample delivery address complete and truly and inform about customhouse conditions of related country not to face problems in sample delivery.
